

Project and portfolio visibility at the Banque Générale du Luxembourg with Niku 6





Luxembourg, July 2004.

The Banque Générale du Luxembourg (BGL, member of the Fortis Group) recently completed the first milestones in the implementation of Niku 6 (renamed Clarity with the release of Niku 7), its project portfolio management application.

Actually, BGL migrated from a previous Niku version: "Niku Portfolio Manager" (NPM), a departmental project management application. Typically, through NPM, the Program Management Office supported scheduling, tracking, and reporting functionality for more than 250 resources within BGL's Information Technology Department.

The challenge

We were challenged by our management to provide real time information about the capacity and the financials status within a project perimeter that was extended to opportunities."

The BGL's PMO is now able to support its strategic planning considering a perimeter that takes into consideration approved and non approved projects. Strategic decisions are now supported by information about the financial status of the projects as well as extended visibility on resource utilization. The PMO can, at any time, disseminate consolidated information that will support grounded selection, when trading off into conflictual situation.
